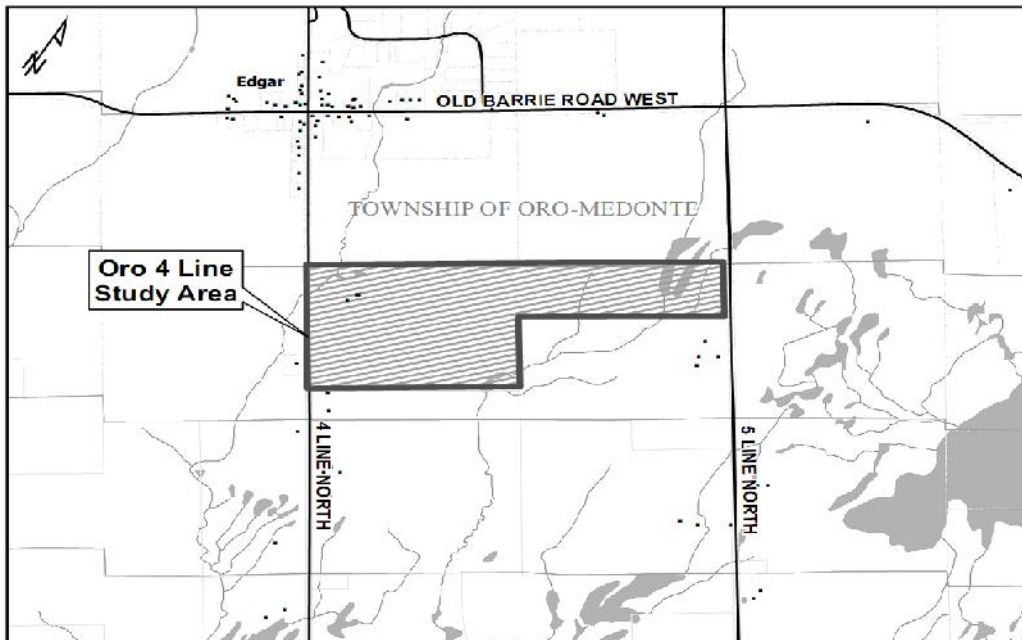
Perpetual Energy Systems is planning to engage in a renewable energy project in respect of which the issuance of a Renewable Energy Approval is required. The distribution of this notice of proposal to engage in this renewable energy project and the project itself are subject to the provisions of the Environmental Protection Act ("Act") Part V.0.1 and Ontario Regulation 359/09, as amended ("Regulation"). Under the Renewable Energy Approvals a key part of the process is the undertaking of public consultation. The purpose of this Notice is to invite your participation in the approvals and dialogue process.

Project Description:

Pursuant to the Act and Regulation, the facility, in respect of which the project is to be engaged in, is considered to be a Class 3 Solar Facility and if approved, this facility would have a maximum name plate capacity of 10 MW. The study area for the "Perpetual Cleanpower Oro 4 Line" covers lands located on 4th Line North, near Edgar, in the Township of Oro-Medonte, Simcoe County. The area is generally bounded by 5th Line N to the east, 4th Line N to the west and Old Barrie Road to the north. Within this study area, the proponent is considering a solar project with an electrical generation capacity of up to 10 MW which will interconnect into the Hydro One Networks Inc grid. The project study area is outlined in the map below. This project is being proposed in accordance with the requirements of the Act and Regulation. The Draft Project Description Report titled Perpetual Energy Oro Solar Farm Draft Project Description Report describes the facility as a 10 MW ground-mounted solar facility. A copy of the Draft Project Description Report will be made available for public inspection at the public meeting, at the Simcoe County City Hall, the Township of Oro-Medonte City Hall, and will be available at <http://www.goperpetual.com>.

The Proponent:

Perpetual Energy Systems LLC ("Perpetual") is an Independent Power Producer (IPP) of renewable energy, through solar photovoltaic power plants. Perpetual develops solar projects across North America ranging in size from 500 kilowatts to 20 Megawatts and currently owns and operates several solar power plants across the United States with installed capacity in excess of 10 MW.



The Process:

The Renewable Energy Approval process includes public, aboriginal, municipal and review agency consultation, assessment of the potential effects of the proposed project and identification of measures to mitigate any potential adverse effects, if any are to be found.

Public input is encouraged throughout the Renewable Energy Approval process. Input will be facilitated through two public meetings and the project website: <http://www.goperpetual.com>. The first public meeting will be held, as noted below, to provide a general overview of the project and the Renewable Energy Approval process, and to seek public input.
